Council Signs New Financial Agreement



New Year's revelers danced with happiness as balloons rained down on them at the stroke of midnight during the Q's Rockin' New Year's Eve Party last week. Quechan Tribal members may hold on to the joyous New Year's feeling a little longer in 2013, with the Council's completion of a year-long project to secure better terms for the Tribe's 2007 GO Bonds financing.

One of the final Resolutions passed for 2012 by the Quechan Tribal Council marked their successful completion of one more goal they had set as part of the Tribe's long-term financial management plan. That Resolution completed a covenant amendment to the 2007 Series Governmental Projects (GO) Bonds taken out to finance a number of important projects, chief among them the site preparation and construction of the Quechan Casino Resort.

The amendment went into effect on December 28, 2012. It provides greater protection

of the Tribe's net available assets, generates more than two million dollars in additional income through guaranteed investments over the next ten years, and provides relief from a liquidity covenant which restricted a significant portion of the Tribe's available cash reserves through 2024.

"It was necessary for Tribal Council to address this time-sensitive financial matter with a sense of urgency," stated President Keeny Escalanti, Sr.

"The benefits to the Tribe are tremendous – we couldn't afford to wait and miss this op-

portunity."

Vice President Ronda Aguerro offered further details, stating, "Because of our reductions in government spending and increases in casino EBITDA (profits) over the past couple of years, we have strengthened the Tribe's financial position considerably."

Looking to the future, the Vice President stated, "We have accomplished a lot in a relatively short period of time, but there is still one more major financial transaction to complete. The GO Bonds were issued in 2007 before the eco-

nomie recession so the Tribe was able to secure a very attractive interest rate for these tax-exempt bonds of 6 5/8%."

In exchange for receiving this low interest rate, the agreement with the GO bond holders (known as bond indenture) required that the Tribe secure future GO bond principal and interest payments with an increasing percentage of Tribal cash reserves. But now, as the Tribe looks more toward the future, having greater flexibility is essential in the event that access to cash reserves is

Election Board Turns Contest Over to Community


Less than 24 hours after the polls closed in the December 3rd Tribal Council general election, the Quechan Election Board had their official abstract of the results completed and posted at the Tribal Administration Office on Indian Hill.

The Election Board confirmed in writing that they had completed their official results at 3:00 PM on Tuesday, December 4, and posted a copy of the Official Abstract for the public not long after. In addition to the 15 certified candidates listed on the ballot, they had tallied a total of 86 votes for 32 write-in candidates.

The top vote getter was incumbent Virgil S. Smith, who received a total of 272 votes out of the 548 recorded ballots. Emilio Escalanti, a previous Council member, came in second with 246 votes. Michael J. V. Jack was only 4 votes behind in his first election to the Tribal Council, with a total of 242, followed by incumbent Clivia Cyndee Miller, who received 221. The final spot went to Julianna M. Comet, returning to a seat on the Council after a 2 year absence with 217 votes.

However, the “Official Results” were put on hold within a week, after the Election Board posted a second notice at the Tribal Administration Office announcing a Community Meeting to settle “Two election contests . . . filed by members of the Ouechan Indian Tribe.”

did not identify either the Tribal members filing the contests nor the nature of their challenges to the results.

The Board quoted “Article V.E” (*sic*) of the Quechan Election Ordinance” stating “an open meeting of the Quechan Community must be held to resolve these conflicts before any Certificates of Election can be issued for the candidates to serve on the Tribal Council.”

Article V, Section E of the
Quechan Election Ordinance

outlines the “Alternative Contest Procedure” to be followed whenever a Tribal member contests the election results “based on allegations of misconduct on the part of the Election Board or any member thereof.”

In the case of such allegations, the Board is to convene an Open Meeting which requires the attendance of at least 10% of those who voted in the election. At that meeting, the members of the voting public hold a vote to elect a special Chairman

With a number of Election Board members having resigned soon after the Official Results were posted, and no signatures on the part of the remaining members of the Board attached to the notice of the public meet-

ing, it was not known until the December 28th meeting who had contested the Election, nor which Board members had been accused of misconduct.

However, once the Tribal members began filing in to the

A full week of special Christmas events began on Wednesday, December 12th when the Quechan Parks and Recreation Department threw open the doors of the Community Center to welcome hundreds of community members inside for their Annual Gingerbread House Building Event!

Even though they had dozens of tables lined up east-to-west across the center of the main floor, the staff also had to pull out the bleachers for extra seating as an overflow crowd of families gathered to take part in this increasingly popular past-

time. This year, the Parks and Rec staff spent the first part of the week preparing 250 "kits", each containing 2 peaked gable end graham cracker walls and four additional whole crackers for shorter side walls and roofs.

Volunteers helped them bag white frosting, which the crafters would squirt from a cut corner of their zip-lock bags to glue the walls down on styrofoam foundations, and then "paint" on filligrees, swirls and other decorations for windows and doors.

All sorts of small, colorful candies were available from

the front table near the stage in the Community Center, which the volunteers passed out along with the kits, or delivered to participants table on request as the projects took shape.

No one, it seems, is immune to the call to be creative. While you can expect to see small children excited to get a chance to play with sweet, sticky confections, there seems to be no age limit on this event! Grandma Peggy Meeden was there to help her granddaughter Nicole, while School Superintendent Dr. David Bealer sat nearby, building a house of his own!



Community Meeting Decides Election Outcome

Once the December 28 public meeting upheld the election results, the newly elected Quechan Tribal Council was sworn in on Monday, January 7th, as called for in the Constitution. Community Center at 6:00 PM on the 28th, everyone saw Cristoble Emerson, Priscilla Prettybird and Mona Engler sitting front and center at their own table, and the identities of the contestors was revealed.

By 6:30 PM, Election Board Marshal Don Medart declared that at least 10% of the Tribal members who had voted in the Election had signed in, satisfying the Election Ordinance requirement for the meeting to proceed. The public quickly nominated and elected Mr. Brian Golding as their Chairman, who called the meeting to order at 6:50 PM.

In his December 31st report to the Tribal Council on the results of meeting, Mr. Golding said Christoble Emerson was the first to present his contest's allegations and proofs of evidence. Mr. Emerson had several questions for the Election Board, which they answered. Several questions and comments were also received from the Tribal members in attendance.

After discussion, Mr. Golding

asked for a show of hands to determine whether the Tribal membership in attendance desired to vote on the question of whether Christoble's contest presented evidence sufficient to find that the Election Board engaged in misconduct during the election held on December 3, 2012. A majority present raised their hands in favor of bringing this matter to a vote. Calling for the vote, the Chairman counted 34 "Yes" votes and 50 "No" votes. The vote showed Christoble Emerson was unable to make the case that the Election Board engaged in misconduct during the election.

At that point, Priscilla Prettybird (assisted by Mona Engler) presented the allegations and proofs of evidence contained in her contest. Priscilla and Mona also read an addendum to the contest dated December 27, 2012. After discussion, the majority present did not wish to pursue discussion of the addendum, as it was not filed before the contest deadline.

Both the Election Board and

the Tribal membership asked and answered questions and shared comments with Priscilla and Mona. Eventually, a majority of the Tribal membership indicated by a show of hands that they wished to vote on the evidence presented in the second contest filed against the December 3rd election results.

On this contest, Mr. Golding counted 38 "Yes" votes to 48 "No" votes, so the majority found that Ms. Prettybird also did not show that the Quechan Election Board had engaged in misconduct during the election.

Mr. Golding then asked the Tribal members present if they were prepared to vote on the issue of upholding the results of the December 3rd election. A majority indicated by a show of hands their readiness to vote. Mr. Golding then counted 57 "Yes" votes and 34 "No" votes.

With that vote, the public meeting upheld the election results. The meeting adjourned at 9:02 PM. The new Council was sworn in on January 7th, 2013.

needed.

Tribal Council Member Cyn-dee Miller offered this explanation: "Before we negotiated this amendment, the agreement with the GO bond holders required the Tribe to set aside \$7.4 Million in cash reserves through 2014. Then, the amount nearly doubles after 2014 to \$14.7 Million. Finally, another increase in reserves was mandated in 2017 to bring it to \$21.1 Million."

Had the Tribe been unsuccessful in its bid to renegotiate this covenant amendment, these scheduled restrictions on cash reserves would have made it incredibly difficult for the Tribe to continue to provide essential services to membership and still satisfy its financial obligations.

With the assistance of casino management and a financial advisory team, the Tribal Council issued a special Request for Proposal (RFP) that was sent to eleven separate multi-national banks to solicit bids for a Guaranteed Investment Contract or "GIC." Through an exhaustive review and screening process, Natixis Funding Corporation, a New York corporation guaranteed by a multi-national investment bank, was selected as the highest bidder.

Natixis offered the best interest rate at 1.96% which represented a premium of 16 basis points above the 10-year US Treasury rate. (It is common practice in the financial industry to use basis points to denote a rate change in a financial instrument, or the difference between two interest rates, including the yields of fixed-income securities. A basis point is equal to one hundredth of a percentage

point, so that means the Nataxis offered the Tribe an interest rate 1.6% higher than the U.S. Treasury currently receives on the 10-Year bonds they issue.)

In turn, a one-time deposit of \$10.5M in GO bond cash reserves has been set aside to secure future GO bond principal and interest payments for reinvestment under the Tribe's Guaranteed Investment Contract, which eliminates the requirement to set aside the additional reserves of \$14.7 Million in 2014 and \$21.1 Million in 2017—Millions which would have been tied up under the previous agreement that will now be available for the Tribe's own future plans and growth.

The Tribe will receive a guaranteed rate of return on these reserves and will reinvest the interest income to increase the rate of growth of the investment. As a result, it is projected that the increased value of the fund will enable the Tribe to pay off the bonds three years early and save over \$2 Million in cash.

"We are now in a position to refinance the remaining 2008 Series Gaming Enterprise Revenue Bonds in mid-2013," stated Council Member Miller.

"These bonds total \$97.5M and carry an interest rate of 15% which is very high. We have already received inquiries from several different investment banks that are interested in this transaction, which is good news since we have not yet formally announced our refinancing plans to the investment community."

Yes - 2013 could be a *much* better year, indeed!

YCAT Makes Blue Route Changes, Adds El Centro Route

The Yuma County Intergovernmental Public Transportation Authority (YCIPTA) is making some changes to bus routes in the area, to help those routes run closer to their published schedules.

One route that has had trouble staying on schedule is the Quechan Blue Route Number 5. John Andoh, Transit Director for YCAT says the condition of Arnold Road and the railway crossing into Winterhaven on First Avenue often cause delays.

To improve the efficiency of the Blue Route, YCIPTA will implement a couple of changes to the route beginning next Monday, January 14.

“The first is to discontinue regular scheduled service north of Indian Rock Road,” says Mr. Andoh, in explaining the changes to keep the Blue Route on schedule.

“Of course, YCAT will still have service available for anyone north of Indian Rock who wants it. Those wanting to catch the bus north of Indian Rock

will just have to call the YCAT Information Line at (928) 783-2235 no later than 15 past the hour and request the Blue Route bus pick them up at a designated bus stop north of Indian Rock Road, or if you’re on the bus, let the driver know when you board that you need to get off past Indian Rock Road.”

YCAT is also discontinuing the buses’ trips in the Old Sub-division on the same date. Riders in that area will still be able to catch the Blue Route at the bus stop near the Pipa Market.

Meanwhile, with the recent authorization of Memorandum of Understanding between the Quechan Tribe, YCIPTA, and the Imperial County Transportation Commission, YCAT has added a new Turquoise Route 10 between Yuma and El Centro!

The new route will operate three times a week on a regular schedule, rather than once a week, on call, as it was when El Centro service was provided by Imperial Valley Transit. Route 10 began regular service just this Monday, January 7th.

Turquoise Route 10 will stop at the Paradise Casino every Monday and Wednesday morning at 9:15 AM, head over to the Downtown Yuma Transfer Center at the old Hotel Del Sol to pick up riders in Yuma, and then continue on to stop in Winterhaven (in front of Hub Liquor) at 9:24 AM and then makes another stop at the Q at 9:33 before heading west on I-8 directly to El Centro. It will stop at the El Centro Regional Medical Center and the El Centro bus transfer center

next to the City Hall at 14th and State Streets. Turquoise Route 10 then continues east to make one more stop at 4th Street and Aurora Drive, about a half mile north of the Imperial Valley Mall, before returning to Yuma.

Route 10 then returns to El Centro just after 3:00 PM (Pacific Time) for riders heading to Yuma in the afternoon.

The Saturday morning schedule is much the same, only the first stop at the Paradise Casino takes place at 11:05AM during the winter months.

AWC's catching coach Bryan Casey spent 6 years with the Kansas City Royals before returning to Arizona to coach both high school and college baseball. He joined San Pasqual's head coach Faron Owl to lead an all day winter baseball camp on December 22nd at the high school's athletic field. On the center, Coach Owl and AWC 3rd baseman Hector Valenzuela observe younger members of the camp during their morning practice drills. In the afternoon, Yuma Diablos coach Ron Arviso spent some time popping short flies to watch Ritchie Preciado, Ron Flores, Tim Frost and Danny Flores scramble to catch each ball. Altogether, nearly 50 local players came out to attend the camp.

San Pasqual's head baseball coach, Quechan Tribal member Faron Owl, brought together an all-star group of current AWC players and their catching coach to once again bring a college-level winter baseball camp to the Quechan reservation in December.

The first day of the winter break saw dozens of local students from Winterhaven and Yuma gathering at the San Pasqual High athletic fields to gather around the visitors from Arizona Western College and soak up every nugget of wisdom they could pass along in one day. While Tribal members were able to sign up for free, other players from Little League through high school paid only \$25 to attend the camp.

Younger players gathered in the north field to practice pitching, catching, fielding and snap throws (to catch players trying to steal bases) under the watchful eyes of Coach Owl and the AWC players.

Meanwhile, *Yuma Diablos* Coach Ron Arviso joined AWC catching coach Bryan Casey on

the varsity baseball field to do the same with the high school aged participants.

A Kofa grad who spent six years with the Kansas City Royals organization, Coach Casey returned to Arizona to serve two years as the Head Softball Coach at Scottsdale's Horizon High before coming back to Yuma to join the staff at AWC.

He was joined at the Camp by sophomore Hector Valenzuela, a former shortstop and 3rd baseman at Kofa High who

now covers third for the *Matadors*. Also helping out were two of Hector's team mates, Omar Celaya and Angel Sanchez.

Omar graduated from Cibola High, where he was both a pitcher and third baseman. Now a freshman at AWC, Omar is a member of their pitching stable. Angel meanwhile, covers second base for the Matadors. He had been a shortstop for the *Kofa Kings* up until his graduation in May of 2012.

All members of the *Matadors*

athletic program shared their additional years of experience to help the kids who came out to learn a few tips to improve both their games and their leadership skills on the field. The college players were able to move their students through fast-paced drills to gain the vital "muscle memory" so necessary to success in the game. Once an athlete gains the ability to instantly respond to everyday situations in the game, they can clear their minds to be ready to instantly

come up with the tactics they will use when faced with more unusual developments.

Many of the students who showed up to take advantage of the opportunity were members of Coach Owl's *Yuma Diablos*.

After spending the morning on drills, everyone stopped to line up for pizza, drinks and cookies, passed out by local girls who had volunteered to help out. Some of the *Diablos* took advantage of a little free time at the end of their lunch break to get Coach Arviso to bat a few short balls to them, to practice their skills at anticipating where the ball will go and getting out in front of it quickly.

Players from all age groups then gathered to play a couple of quick games in the afternoon, and put together all they'd learned into a single, seamless flow under the watchful eyes of their coaches.

The most improved players even received baseball bats to take home with them, while everyone involved received their own special AWC Instructional Baseball Camp T-shirt!

Traffic to be Detoured for Power Line Reroute

The Imperial Irrigation District (IID) will be re-routing electrical power lines later this month, as the first step in the installation of a new water storage tank on Indian Hill.

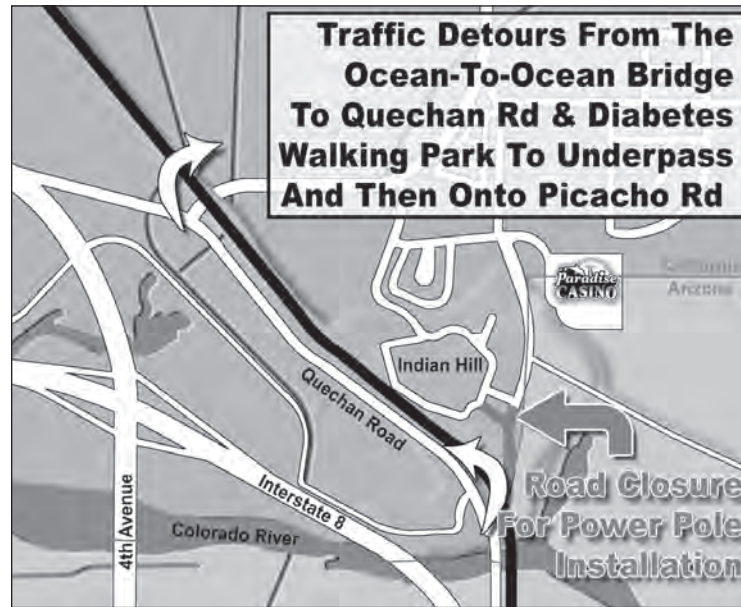
A power pole just north of the current water tower sits right where the new water storage tank will be, so the existing power lines will be moved.

The work is currently scheduled to begin the week of January 14, 2013. It is anticipated the project can be completed in five workdays, each lasting from 6:00AM until 3:00PM. During those hours, traffic will be rerouted around the Indian

Hill worksite in two phases.

Phase One will close Quechan Drive for up to two days, from the Saint Thomas Mission parking lot to the IHS Clinic entrance. Phase One will involve drilling holes and installing three new power poles on Indian Hill. Traffic coming north across the Ocean-To-Ocean Bridge will detour to the west along Quechan Road, past the Diabetes Walking Park, heading through the railway underpass onto the reservation.

Traffic bound for the Paradise Casino and Indian Hill Administrative area will then be directed south on Indian Road



Traffic will detour along Quechan Drive during the power line project.

101. Those heading to the Old Sub and other points north will continue on Picacho Road.

Meanwhile, for traffic coming from the housing areas, Quechan Drive south up Indian Hill to the IHS Clinic's front drive will remain open.

Phase Two will be much the same, with Indian Hill Drive (in front of the Quechan Police Department building) closed for up to five days, from the west side of the QPD office to Quechan Drive. Phase Two will see IID crews removing the original power pole that is in the way and rerouting the power line to the new power poles.

The teaching staff at the San Pasqual schools has increased by two, as Larry Cornellison and David Hofland joined the faculty in late December.

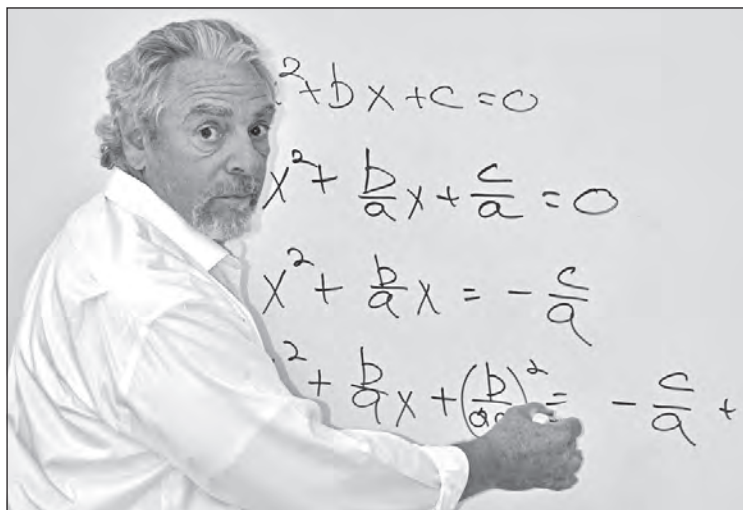

Later in life, he went on to earn a Masters in history, an MBA, and a teaching certificate. He has since completed his Ph.D. in education and is currently conducting the field work needed for an administration certificate . . . at 65!

“I grew up in Glendora, California, where I went to Glendora High School,” he tells the *Quechan News*, “Where I was a member of both the swim team and the football team.”

He met his wife, Susan, in Santa Monica when he stopped to help her with a little car trouble, and they dated four years before getting married in 1968.

“It was important that she finish her education, he explains, “as she was still in school to be-

come a Registered Nurse.”

“At 40 I sold the company and retired to Julian. We built a big house, had horses, tractors, fast cars and I got bored. So I

Larry and his wife have four grandchildren: two grandsons (from their son) and two granddaughters (from their daughter). Their oldest grandchild is in the 10th grade, and the other three are currently in middle school.

Davis Hofland also joins the faculty this week, as the new Music Director for all grade levels at the San Pasqual Valley Unified School District.

A native of Torrance, California, Mr. Hofland attended the Academy of Math and Science,

a public magnet school on the campus of the California State University of Dominguez Hills in Carson. While at CAMS, he played guitar in a rock band.

After graduation, he moved to Providence, Rhode Island to attend Brown University, studying cultural anthropology, neuroscience, and Chinese religion and language, among other subjects. Shortly after graduating, he picked up the electric bass, “Which led to the musical love of my life,” he says, “the double bass.”

Explaining how he ended up where he is today, he contin-

Meanwhile, I was playing jazz bass at the local community college, while I studied singing, music history, and music theory. The Quechan Enrollment Application deadline for the 1st quarter of 2013 is Friday, March 1, 2013 at 5:00PM(MST). Completed applications must include the following support documents:

- State Certified Birth Certificate (Copy)
- Social Security Card (Copy)
- If either parent is an enrolled member of another tribe, submit an updated Certified Degree of Indian Blood (CDIB) and a letter of non-enrollment for the applicant.

Applications will not be processed until all the support documents have been received. Completed applications are processed quarterly.

The Quarterly Meeting for the Enrollment Committee will be scheduled for Mid-March, 2013, to review those applications and forward them to the Tribal Council for approval.

The Quechan Diabetes Program hosted their second 5-man Flag Football Tournament on Friday, December 14, 2012.

"The Tournament was put together to get members in the community to come enjoy a game of football and get the chance to burn a massive amount of calories while having fun at the same time," said Sandy Palone, Director of the Quechan Special Diabetes Program for Indians (SDPI).

A total of 52 people came out to the event. Six teams of adults signed up for this fast paced double-elimination tournament, held at San Pasqual's Warrior Football Field beginning at sundown.

Unfortunately, the youth division only had one team signed up, so with no opposing team to go up against, the "Toxic Grenades" were unable to compete that night.

"We still want to thank the "Grenades" for putting in a team," said Mrs. Palone, "and we hope to see them back when

we try again in the spring."

The Tournament was organized for teams to include players ranging from age 12 years old and up.

Each game was held on an eighty-yard field allowing only twenty minutes and three downs to convert a "first down" or a touchdown.

"All of the teams were very exciting to watch," according to Sandy, who also said the Diabetes Program would like to thank each team and its players for participating in the event:

"First place at the Tournament went to *The Whatevers*, second to *The Rocks*, third to *Team Pen*, fourth to *Go Hard*, with fifth place going to the *Yuma Delinquents*, and sixth to *The Doggie Doggs*. We also want to give a *special thank you* to the San Pasqual Valley Unified School District for the use of their facilities, to Quechan Parks and Rec. for the use of their equipment, and to all the spectators who came to watch these exciting match-ups!"

Looking For Lunch? Try Pepper's Café At the McCoy Mobile Home/RV Park!

When you head over to Winterhaven on Arnold Road to pick up groceries or visit the Post Office, you pass by the McCoy Mobile Home and RV Park just before the railway crossing on the east side of town. If you look closely, there is a sandwich board sign at the main gate of the Park, advertising daily specials at Peppers Café inside.

Who knew there was another option for lunch, so close by?

The Park and the Café are both owned and operated by Quechan Tribal member Patrick A. McCoy and his wife, Jonnie.

"My parents, Robert and Alyce Mae (Black) McCoy began developing her 10-acre allotment in 1975," explains Patrick. "The allotment belonged to my grandmother Rosalie Black, which was handed down to my mother Alyce Black McCoy and now it's come down to me. Back in the early '70s, three acres of my grandmother's allotted land was primarily covered with slew water, wild cottonwood, mesquite and arrow weed, some of it 20 feet high!" With the water and overgrowth, the entire ten acres was deemed inappropriate for farming by the Bureau of Indian Affairs.

Patrick continues the story. "But the beautiful part was that large birds and giant wild plants grew in here alongside the water," he says, "and during the summer this would revert back to the typical desert landscape. My mother claimed the frogs and turtles were here as part of our ancestral clan."

They came up with a plan to develop the property after the occasional boondocker and other squatters had begun to store

farm equipment, travel trailers on it. And without the McCoy family's approval, they were receiving no rent or benefit! So they hired the squatters who were living in his grandmothers old wooden home (which sat on stilts to keep it dry) to act as "managers", to watch over their land and collect rents.

"Within a few months they had sent my mother two hundred dollars, so a month later I drove down here from Costa Mesa with her to see the new developments." They ended up buying their "managers" \$200 worth of groceries at Safeway, since they hadn't had much to eat in the meanwhile. "My mother always wanted her income to be spent to, 'help those who have less'", he says, "and she had rented out her property to people who really needed a place to stay."

Patrick's dad soon set up a small trailer to use on weekends and whenever he had time, and began clearing the land.

"I remember meeting him here with a small loader/tractor I borrowed from a friend in Redlands. I could not imagine why, but the summer heat kept me away from here until 1987

when my wife and I brought down an old two-bedroom trailer to live in part time." They returned to Palm Spring until 1991 when, their son Patrick A McCoy II was born, and then chose to move here and assist their parents as the park grew. By 1995 the park had 120 spaces. It stayed more than half full during the summer, awaiting the busier months when the winter visitors returned.

Patrick's wife Jonnie has been the park's manager since 1993, while Patrick works primarily as their "grounds keeper". He also worked for a while at the Paradise Casino in 1995, and later moved over to the Quechan Casino Resort when it opened. He returned to the Park full time in 2008.

"We're now assisted by our office manager, author Pinkie Paranya" he relates. "She has been a fantastic find, coming from the closing of Fort Yuma Trailer Village. We also now have a real maintenance and grounds keeper in our friend Mario Vera."

With the extra help, they've been able to open and operate a seasonal "Pepper's Café" in the

Park. Patrick says "the food is very reasonably priced and extra delicious."

Open from October through April each year, Pepper's Café serves a Breakfast Buffet with eggs, bacon, sausage, and potatoes sautéed with onions and red and green bell peppers. You even get free coffee with the breakfast buffet! The buttered toast selection includes sour-

dough, whole grain and Russian Rye . . . all for only \$2.99 a single serving or \$3.99 for all you can eat!

Pepper's breakfast buffet line is set up from 9:00 AM until noon, when they switch over to lunch specials that last until 3:00 PM.

The typical lunch choices include Hamburgers and Cheeseburgers with lettuce, vine rip-

ened tomatoes, red onions and mayo. Their BLTs have bacon, lettuce, tomato, mayo on your choice of breads. All lunches include chips and a dessert (!) and you can also get extras like pickles, pineapple, jalapenos, and peppers upon request. All for the lunch special price of only \$4.99!

Sodas, water iced tea and juice are only a dollar, while the coffee at lunch is also FREE!

"We may even have free vegetables or fruit, depending on what we have in the kitchen," according to Patrick.

They've even stayed open a little later on Fridays a few times over the past few years, to have dinner specials and fish fries. If business allows, they hope to do the same kinds of things this coming spring.

Both Patrick and Jonnie say that the most important achievement of their lives has to be that their son Patrick McCoy II has stayed with them, learning and studying all the aspects of owning and securely operating their "family park".

"He's nearing 22 years of age," says Jonnie McCoy, "and

he's joined forces with us as an owner/manager as well." Their rents are affordably priced, and they even accept children.

Jonnie continues plugging their operation: "We also have a library with movie rentals, an exercise gym and you will find our pool is cool, the Jacuzzi is hot and everyone living here are the finest and friendliest neighbors you will find."

So, the next time you find yourself heading into Winterhaven on a weekday errand, keep Peppers Café in mind, and stop in for a bite to eat!
