Compliance Corner:

Firearms Policy Reminder

To ensure the safety of all residents, please remember the following guidelines regarding firearms in QHA-managed units:

- Registration of Firearms: All firearms must be registered with QHA prior to occupying a unit. If you already possess firearms, please register them with QHA within five days of receiving this notice. New firearms must also be registered within five days of acquisition.
- Storage & Security: Firearms must always be stored securely in a locked container within the unit. They should be unloaded unless being transported to or from the unit.
- Firearm Inspections: QHA reserves the right to inspect firearms during scheduled inspections to ensure they are being stored securely
- Carrying Concealed Firearms: If you have a valid California Carry Concealed Weapon (CCW) license, you may carry a concealed firearm within the unit, but it must remain unloaded and secured at all times. You must provide a copy of your CCW license and firearms safety certificate to QHA.
- Firearm Violations: Possessing an unregistered or unsecured firearm can result in a written warning and possible termination of occupancy. Violations of this policy, including discharging a firearm or threatening others with a firearm, may lead to termination of occupancy.
- Reloading Ammunition: The reloading of ammunition is prohibited in QHA-managed units.

We take these policies seriously to ensure a safe and secure community for everyone. If you have any questions or need assistance with firearm registration, please contact the office.

Lemon Berry Muffins —*



These bright and fluffy muffins are a simple, tasty treat that's perfect for spring!

Ingredients:

- 1 ½ cups all-purpose flour
- ½ cup sugar
- 2 tsp baking powder
- ½ tsp salt
- 1 egg
- ½ cup milk
- 1/4 cup vegetable oil
- 1 tsp vanilla extract
- 1 tbsp lemon zest
- 1 cup fresh or frozen mixed berries (blueberries, raspberries,



Preheat oven to 375°F (190°C). Line or grease a muffin tin.

In a large bowl, mix flour, sugar, baking powder, and salt.

In a separate bowl, whisk together egg, milk, oil, vanilla, and lemon zest.

Combine wet and dry ingredients, then gently fold in berries.

Spoon batter into muffin cups and bake for 18-22 minutes, or until golden and a toothpick comes out clean.
